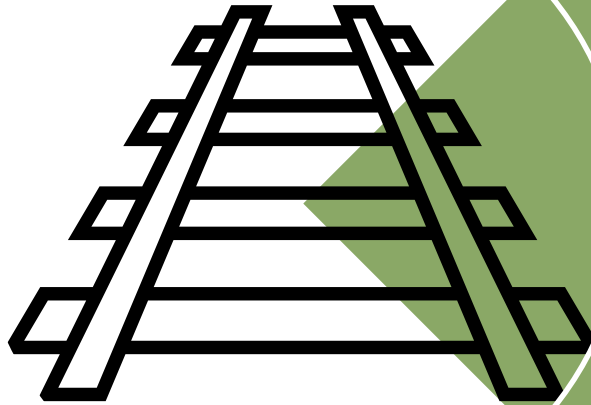

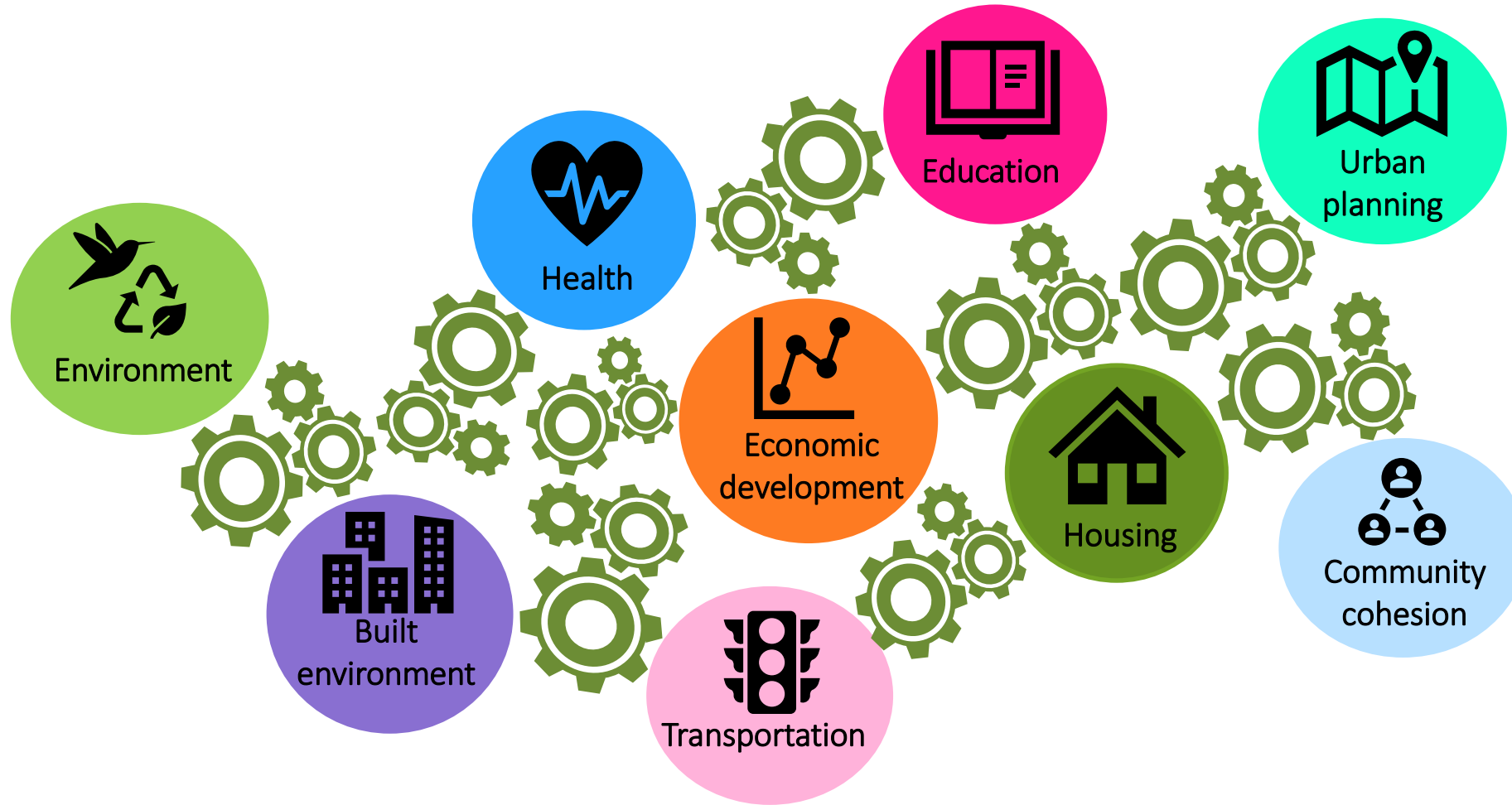

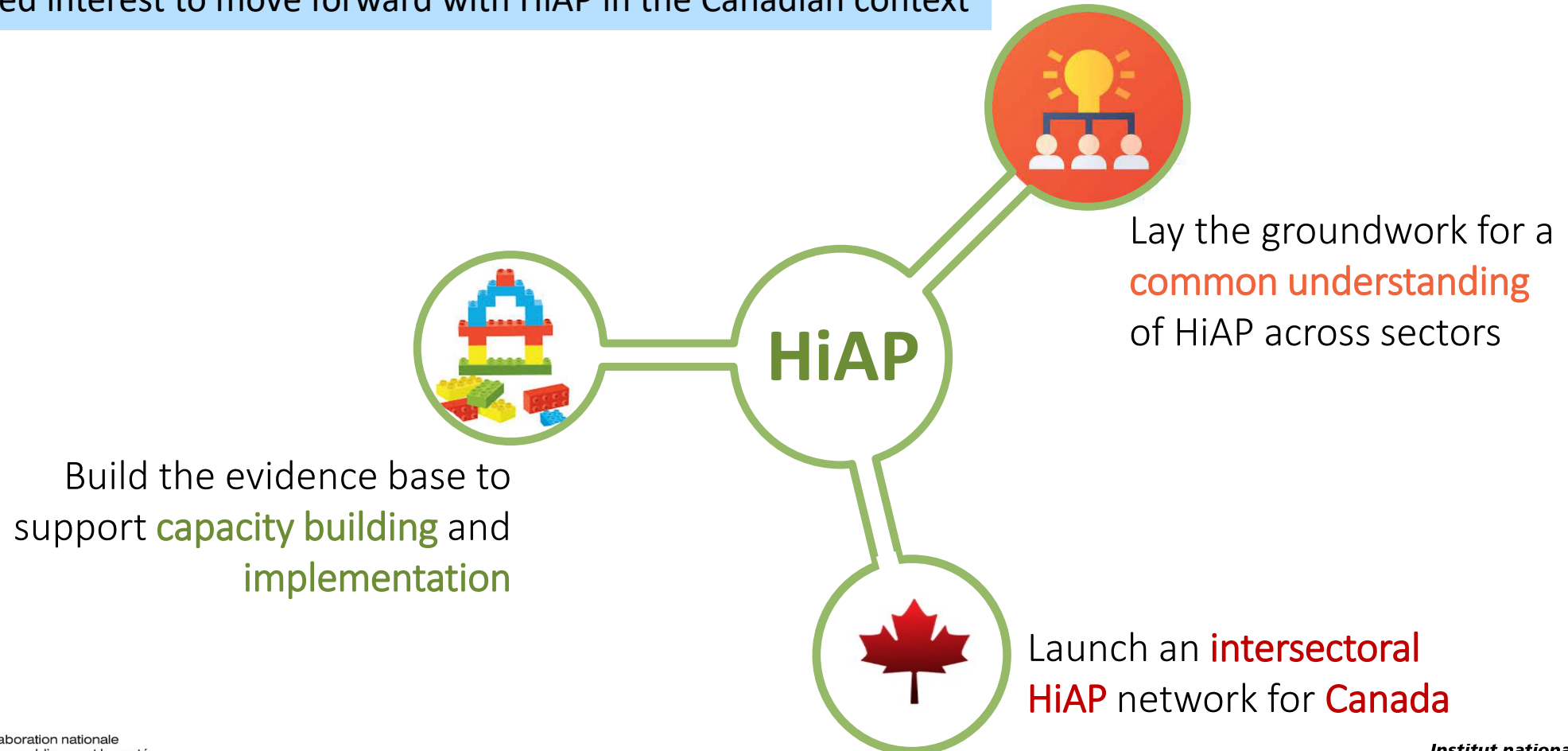

Network's Goal & Objectives

GOAL: The goal of the CNHiAP is to facilitate, through knowledge mobilization, the uptake and implementation of Health in All Policies (HiAP) approaches in Canada.

OBJECTIVES:

- **To expand knowledge** about HiAP implementation in Canada.
- **To facilitate partnerships** between public health actors working on, or interested in, HiAP.
- **To support capacity building** for HiAP among public health actors in Canada.
- **To work with First Nations, Inuit and Métis partners** towards developing HiAP approaches that recognize and incorporate their ways of knowing and governing.

- Membership can be individual or organizational/institutional.

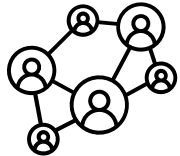
