Background

- Reinstating/rebuilding healthy communities and partnership work
- Summer 2024: media coverage on harms of fluoride and water fluoridation (CWF) including a Florida court case
- Decided to dedicate staff time to unpack what was showing up in media and how studies were being used to position the issue of fluoride and CWF safety.
- Fall 2024 Social Media Posts Consents and Fluoride Varnish Program
- Town Decision to Remove Fluoride not communicated to public health and community
- Uncovered more CWF withdrawal in the largest municipality without communication or connect to identify the health impacts

Understanding the Policy Context

- Critical thinking and decision making
 - Understand how the issue is being positioned in community and in media and deciding to move forward
 - Anticipate and then Prepare
- Critically appraising evidence: systematic review, technical reports, court proceedings/recommendations
- Monitoring, assessing and revisiting relevant research and information as it evolves
- Established an in depth understanding of what information/misinformation is driving the dialogue
- Completed a synthesis of research and other evidence
- What is the information saying and not saying- Not understating or overstating the findings
- Build and Maintain Credibility and Trust and Instill Confidence

Internal <u>Communication</u> to Build Alignment and Understanding

- Ensure there was alignment in interpretation of science, reports (policy analysis)
- Establish common key messages
- Support staff to be equipped to speak to the questions and opportunities that were emerging
- Front line staff:
 - Implementing a Fluoride Varnish Program in Schools → Dental Hygienists- Questions from Principals and Parents
 - Holding and Rebuilding Partnerships with Municipalities → Health Promoters -Being equipped
 to host conversations with Municipalities regarding their decision/the issue

Communication

- Understanding the dialogue on the issue and find ways to reframe: In conversation and In writing
- Writing skills: Science Brief- Academic writing; Plain language Knowledge Translation
- Framing/Re-framing Techniques to Establish Plain Language Tools
- Understanding and application of Framing techniques (examples: Frameworks Institute, PHRASES, Berkley Media).
- Studying how the information and dialogue is being positioned by those with alternative views
- Knowing audience and who you are communicating to and why
- Webinars: Presentation tools/skills and using on-line mediums for training and communicating
 - Being a Reflective Practitioner what worked, what didn't try again

Partnership/Collaboration

- Invest in relationships and showing up
- Invest in Understanding Partners
 - structures and process- municipalities
 - mandate and context and priorities
- Understand Current Players and their Perspectives and their position on various issues
- Seek to understand, avoid assumptions about why policy decisions are being made

Partnership/Collaboration

- Maintenance of partners
- Art of difficult conversations and reframing of current dialogue to provide a health lens
- Balance addressing current issue/opportunity while also focusing on "the long game"
- Knowing how to raise concerns and provide a health in all policies perspective with the municipality without damaging relationships for additional/future work – for example: housing policy, equity and anti-racism plan etc.
